Nyhetsbrev fra samferdselsråd ved Norges delegasjon til EU

EU. Samferdselssaker og -møter uke 22/2021

- **Kommisjonen presenterer utkast til oppdatering av rådsanbefaling om fri bevegelse innad i EU**
- **Rådet vedtar sitt syn på Mobilitetsstrategien av 9. desember 2020**

Forslag til oppdatert rådsanbefaling

Kommisjonen presenterte 31. mai forslag til utkast til oppdatert rådsanbefaling 2020/1475 om reising internt i Schengen/EØS, som ble vedtatt pga. covid-19 pandemien. I pressemeldingen siteres EUs justiskommissær bl.a. slik: «... Member States are now slowly lifting COVID-19 restrictions both domestically and regarding travel. Today, we are proposing that Member States coordinate this gradual lifting of free movement restrictions, taking into account our new common tool: the EU Digital COVID Certificate. We now expect Member States to make best use of this instrument and the recommendation to allow everyone to move freely and safely again.”. I utkast til rådsanbefaling foreslås det bl.a. at fullvaksinerte med vaksinesertifikat skal unntas fra testing ifm. reiser og karantene 14 dager etter vaksine og at mindreårige, som reiser med foreldre, skal unntas fra karantene om foreldrene slipper dette. Utkastet vil bli diskutert på et kommende IPCR-møte.

Hva gjelder transportarbeidere og -tilbydere spesielt foreslår Kommisjonen en endring i punkt 19a. Iht. den gjeldende rådsanbefalingen skal hurtigstester brukes ved testing av slike arbeidere / -tilbydere. I utkast til oppdatert rådsanbefaling foreslås det, forenklet sagt, et testunntak for transportarbeidere / - tilbydere som har et vaksinesertifikat utstedt etter reglene for EUs digitale covid sertifikat eller et sertifikat, utstedt etter de samme regler, der det dokumenteres at det har gått 180 dager siden første positive covid-test.

Kommisjonen foreslår også at medlemslandene vurderer å kreve at passasjerer som kommer til landet, med kollektive transportmidler, med forhåndsreserverte plasser, skal sende inn passasjerlokaliseringsskjema (PLF). Medlemslandene oppfordres her om å anvende det digitale PLF-skjemaet fra [EU Healthy Gateways](#), inkludert å delta i PLF-plattformen "...to enhance their cross-border contact tracing capabilities for all transport modes."

Kommisjons utkast til oppdatert rådsanbefaling ble presentert s.d. som luftfartsorganisasjonen IATA og ITFs [felleserklæring](#) på International Cabin Crew Day. I felleserklæringen oppfordres det om å prioritere vaksinering av flybesetning, i tråd med ICAOs anbefaling og i tråd med WHOs anbefaling om å prioritere transportarbeidere som sådan. Passasjerene oppfordres også om å rette seg etter covid-19 regler og prosedyrer, inkludert bruk av ansiktsmaske. I den sammenheng oppfordres også til ratifisering av Montreal – protokoll 14 om uregjerlige passasjerer om bord på internasjonale flygninger.

Mobilitetsstrategien

EUs transportministre møtes i Luxembourg 3. juni. En sentral sak på møtet blir å vedta et felles syn på Kommisjonens [Mobilitetsstrategi](#), som ble presentert 9. desember i fjor. En mer bærekraftig, smart og robust transportsektor står sentralt i strategien.

I [utkast](#) til rådkonklusjoner gir EU-landene støtte til Kommisjonens transportvisjon, og ikke minst til at transporten bidrar til å sikre at EU når klimanøytralitet i 2050. I utkastet understrekkes det, mer tydelig enn i strategien, at alle transportformer må bidra til klimareduksjonen parallelt med ambisjonen om et modalt skifte. Rådkonklusjonene inneholder ingen føringer knyttet til om en felleseuropisk dato for utfasing av salg av nye biler med forbrenningsmotorer. I utkastet understrekkes det også at utslippsmålene må nås på den mest kostnadseffektive måten, og at alle EU-landene må delta. Her må man imidlertid ta hensyn til «... fairness and solidarity and Member States' different starting points and specific national circumstances, including those of island Member States and islands, while leaving no one behind». Senere i utkastet understrekkes det også at EUs transportpolitikk må være inkluderende og tilgjengelig for alle, inkludert at man må "... combat transport poverty». Transportpolitikken fremover må også styrke de sosiale forholdene i sektoren. Hva gjelder dette punktet kan man merke seg at 11 europaparlamentarikere 28. mai skrev til transportkommissær Välean og protesterte på beslutningen om å utsette revisjon av forordning 1008/2008 om luftfartstjenester fra 2021 til 2023. Parlamentarikerne fremhever i brevet at «Further delays means that the crisis will continue to undermine social standards and distort competition in the European aviation market».

Utkastet understreker også viktigheten av å slutføre det transeuropeiske transportnettverket (TEN-T) innen de fastsatte tidsfristene, dvs. år 2030 for kjernenettverket og år 2050 for det mer omfattende nettverket. I den forbindelse vises det til at Kommisjonen 26. mai presenterte sin evaluering av TEN-T forordningen, der styrker, svakheter og erfaringer med dagens forordning gjennomgås. Det legges til grunn at denne evalueringen vil danne grunnlaget for kommende TEN-T revisjon til høsten. Behovet med å redusere et årlig finansieringsgap på hele 230 mrd. euro, for å lykkes med å nå ambisjonene i strategien fremheves også i utkastet.

I utkastet fremgår det også at medlemslandene ser frem til Kommisjonens kommende bymobilitetsinitiativ, som vil være en revisjon av bymobilitetsstrategien fra 2013. Her understrekkes bl.a. betydningen av aktiv mobilitet, kollektivtransport og nye mobilitetstjenester. Se for øvrig nedenfor under «Nyheter DG MOVE», der Kommisjonen informerer om frem konsultasjoner nå i juni på kommende revisjon.

Utkastet presiserer også viktigheten av å ta hensyn til den internasjonale dimensjonen for å sikre konkurransedyktighet for den europeiske transportindustrien og at EU fortsatt må spille en aktiv rolle i internasjonale fora «...most notably in the context of establishing global standards and maintaining a level playing field»

Lastebilorganisasjonene fra de nordiske landene (NLA), fra Frankrike (FNTR) og Tyskland (BGL) har nylig også presentert sin fellesposisjon på EUs grønne giv. Posisjonen oppfattes ikke minst som et innspill til den kommende «Klar for 55»-lovpakken, som Kommisjonen forventes å presentere nå 14. juli. I fellesposisjonen konkluderes det bl.a. med at man allerede i 20 år har bidratt til bærekraft og at man vil fortsette fremover, at «modalt skifte»-ambisjonen er utdatert, samtidig som det presiseres at man allerede i dag samarbeider med andre transportformer «...on an equal footing», at næringen behøver en sikker investeringshorisont og at insentiver til nye løsninger er helt essensielt. I posisjonen understrekkes også behov for tilgjengeliggjøring av alternative drivstoff og infrastruktur for slikt drivstoff, grensekryssende transport med lengre kjøretøy (modulvogntog) og at man må forhindre «lappeteppet» av ulike lokale byrestriksjoner på transporten.

Ryanair-episoden forts.

I nyhetsbrevet uke 22/2021 ble det informert om Det europeiske Råds (DER) konklusjoner 24. mai, der man reagerte sterkt på den tvungne landingen av Ryanair-flyet i Minsk og på fengslingen av Raman Pratasevich and Sofia Sapega. Det ble her også informert om EASAs pressemelding 26. mai om sikkerhetsbefaling om luftfartsoperasjoner i hviterussisk

luftrom og at saken forventes å bli diskutert på Transportministermøtet 3. juni. Det er nå bekreftet at Litauen vil bringe saken opp på dette møtet.

Europaparlamentets president, David Sassoli, ga 25. mai støtte til DERs konklusjoner. Her oppfordret han også europeiske lufthavner «...to exhibit photos of the detained blogger and journalist Roman Protasevich as a mark of solidarity.». Han siteres slik i oppfordringen: «We welcome the targeted and personal sanctions against members of the Belarus regime, the blocking of overflights over Belarus for EU airlines, and measures against Belarusian airlines, in particular Belavia. I also think it would be a very positive gesture if a photo of Roman were to be displayed in the main airports of European Union member states, as a mark of solidarity and to show that we will not fail him».

Kommisjonen presenterte 28. mai så sin pressemelding «Plan for €3 billion support package to democratic Belarus», inkludert til å styrke transport- og handelsforbindelsene på grensen mellom EU og Hviterussland så fremt landet går over til et demokratisk styre.

31. mai kom pressemeldingen om industrikommisær Bretons besøk til Litauen, der han bl.a. møtte passasjerer på Ryanair-flyet. I anledning besøket holdt han en tale, med tittelen «Europe will never turn a blind eye or any country hijacking our rights». Her følger et utdrag fra talen: «... We are closing our airspace to planes from Belarus and calling on EU airlines not to fly over the country. And, in addition to the 88 individuals and 7 entities now designated under the EU sanctions regime on Belarus, we will present new sanctions on Belarus, including economic ones...The Ryanair hijacking shows that we are facing a new level of threats... we must realise that we cannot take anything for granted not even the security of our civilian air space... We are ensuring the security of our air space, the integrity of our territory and the defence of our cyber space.... I am also working on establishing a European cyber shield to secure our digital space. A European Network of Security Operation Centres (SOC) will detect and counter the low signals of cyber attacks, before they are activated. For obvious reasons, I want one of these European SOCs to cover the Baltic region».
