Nyhetsbrev fra samferdselsråden ved Norges delegasjon til EU

EU. Samferdselssaker og -møter uke 45 og fremover

- **Transportforslag i «Klar for 55»-lovpakken forventes diskutert i COREPER 12. november.**
- **Rådet godkjenner kompromisset med Europaparlamentet på revisjon av «Eurovignette»-direktivet.**
- **Kommisjonen ber om innspill til revisjon av lufttransportforordningen.**

«Klar for 55»

De tre transportforslagene (forslag til forordning om infrastruktur for alternative drivstoff (AFIR), ReFuelEU Aviation-initiativet og FuelEU Maritime-initiativet), se [Samferdselsnytt uke 28](#), forventes diskutert på Rådets ambassadørsmøte (COREPER) 12. november.

Til møtet er utarbeidet et [diskusjonsdokument](#). Dokumentet gir bl.a. en kortfattet status på behandlingen av forslaget. Her går det frem at man har kommet lengre med behandlingen på AFIR-forslaget og ReFuelEU Aviation, enn på FuelEU. På sistnevnte forslag fremheves også sammenhengen med flere av de andre forslagene i lovpakken, noe som delvis kan forklare at man har kommet kortere i behandlingen på dette forslaget.

COREPER bes i dokumentet om å gi sitt syn på sammenhengen mellom transportforslagene og andre relevante «Klar for 55»-forslag. Videre om man skal forsøke å nå en felles

rådsposisjon på AFIR og ReFuel Aviation på kommende transportministermøte (TTE) 9. desember. En slik avklaring fremstår som naturlig, siden TTE-agendaen trolig vil bli vedtatt på neste COREPER-møte 17. november.

Europaparlamentet har, på sin side, ikke påstartet sin komitebehandling av forslagene ennå. Den videre prosessen der er derfor fortsatt uklar.

Det er interessant å se prosessen på transportforslagene i «Klar for 55»-lovpakken, inklusive forslaget om reviderte CO2-standarder for person- og varebiler, i lys av COP 26-møtet som pågår i Glasgow nå.

På transportdagen 10. november ble bl.a. deklarasjonen om overgang til nullutslippsbiler og «Drive to Zero» - initiativet om tyngre nullutslippskjøretøy lansert. International Aviation Climate Ambition Coalition hadde også sitt første møte på transportdagen. Denne koalisjonen forplikter seg bl.a. til fremme utviklingen og utrulling av innovative ny lav- og nullutslippsteknologi for fly – et fokusområde også for EUs nye fellesforetak Clean Aviation under forskningsprogrammet Horisont Europa. I den sammenheng vises det også til Kommisjonens nye konsultasjon om å etablere en fremtidig industriallianse om fornybart drivstoff med høringsfrist 30. november. «Eurovignette»

Rådet stadfestet kompromisset på revidert Eurovignette – direktiv 9. november, se Rådets pressemelding her og nedenfor under «Rådets pressemeldinger». Rådets beslutning følger opp COREPERs tilslutning til kompromisset 30. juni, se Samferdselsnytt uke 27/2021.

Europaparlamentets Transportkomite (TRAN) forventes nå å diskutere utkast til anbefaling om å godkjenne kompromisset på sitt møte 1.-2. desember, og deretter å stemme over anbefalingen etter årsskiftet. Forutsatt at TRAN støtter anbefalingen, kan endelig avstemming finne sted på EPs plenumssesjon i februar 2022. EU-landene vil deretter ha to år på seg til å gjennomføre direktivet i nasjonal rett.

Revisjon av lufttransportforordningen

Lufttransportforordningen (forordning 1008/2008) om felles regler for utøvelse av luftfart er tatt inn i EØS-avtalen og gjennomført i norsk rett. Kommisjonen ber på sin høringside om innspill til revisjon av forordningen. Høringsfristen er 6. desember.

Revisjonen ble bl.a. varslet i Mobilitetsstrategien 9. desember 2020, se utdrag punkt 85-86:

«85. The integrity of the single market and a level playing field for operators must be maintained, including by ensuring that there is no discrimination among incumbents and new market entrants, for instance when granting State aid, and that no new barriers for competition are introduced... 86. To achieve all the goals in this strategy, support for modernisation efforts is needed in every mode to provide EU citizens with smart connectivity at affordable and transparent prices. In aviation, the Commission will propose to revise the Air Services Regulation...».

Kommisjonens innspillsnotat adresserer flere problemstillinger, som er strukturert etter tre punkter. De to første knytter seg til erfaringene med Covid-19 pandemien så langt, nærmere bestemt rundt flyselskapenes økonomiske soliditet og robusthet og rundt muligheten til å reagere raskt for å sikre flyforbindelser og logistikk-kjeder. Det tredje punktet knytter seg til behovet for å justere forordningen i lys av Mobilitetsstrategiens fokus på en mer bærekraftig og sosial ansvarlig luftfart. Her fremheves det bl.a. at «... Many stakeholders see a link with ineffective enforcement of existing national labour law rules by the countries responsible to the detriment of aircrews and competitors. This can result in competitive distortions and an uneven playing field as well as ineffective protection for aircrews». Her vises det også til at en av målsetningene fra Mobilitetsstrategien om å gjøre «... scheduled collective travel under 500 km within the EU carbon-neutral by 2030». Utover å vise til transportforslagene i «Klar for 55»-pakken, varsles det om ytterligere tiltak fra Kommisjonen. Andre temaer som nevnes er økt pristransparens, trafikkfordeling og mangel på regulatorisk klarhet knyttet til dronebaserte tjenester.

I Mobilitetsstrategien ble revisjon av forordningen varslet i 2021 - 2022. Revisjonen er imidlertid ikke omtalt i Kommisjonens arbeidsprogram for 2022. Det er derfor grunn til å tro at endelig forslag til revidert forordning først vil bli presentert i 2023. Postrapporter

Kommisjonen presenterte 8. november to rapporter om situasjonen og utviklingen på post- og pakkemarkedet. Rapportene kan finnes [her](#). Kommisjonen fremhever her bl.a. at de to regelverkene («Postdirektivet») og («Pakkedirektivet») har «...successfully accompanied the modernisation and opening of the European postal services and ... ensured that all EU citizens have access to essential letter and parcel services». Kommisjonen mener også at rapportene viser også hvordan digitalisering har endret markedet, inkludert skapt nye muligheter og utfordringer for postoperatørene og nye forventninger hos brukerne. Videre at regelverket har bidratt til å sikre rimelige universielle tjenester i EU, samtidig som det erkjennes at mange medlemsland har redusert funksjonene og omfanget av slike tjenester. Det skal i hovedsak skyldes økte kostnader forbundet med slike tjenester og endrede behov.
