Transportinitiativ og møter i lys av Ukraina-krigen

Europakommisjonen presenterte 6. april forslag til **forhandlingsmandat med Ukraina og Moldova**. Formålet er å liberalisere veitrasporten for operatører fra nevnte land så lenge krigen pågår. Det ukrainske forhandlingsmandatet inneholder også bestemmelser om anerkjennelse av ukrainske førerkort og kompetansebevis. I Kommisjonens pressemelding siteres kommissær Välean slik: “Today, we propose to conclude transport agreements with Ukraine and Moldova by partly liberalising road transport for their hauliers in the EU. This will allow Ukraine to shift important export goods from sea routes – currently unavailable due to the Russian military aggression. The blockage of the Black Sea ports has also negatively affected Moldova, which has lost essential transport routes through Ukraine for its own exports, and whose economy has been heavily impacted by the war in Ukraine. Our proposal will provide immediate relief to the economies of these two countries”. Rådets transportarbeidsgruppe diskuterte forslagene senest 28. april 2022.

Kommisjonen presenterte 5. april forslag til **nye sanksjoner på Russland og Hviterussland** («femte sanksjonspakke»). Sanksjonspakken inneholder bl.a. et forbud mot russiske fartøy i europeiske havner og forbud mot veitrasport for russiske og hviterussiske operatører (inklusive transitt). Rådet vedtok de nye sanksjonene allerede 8. april. Rådets pressemelding s.d. med nye sanksjoner overfor russiske personer og selskaper kan finnes [her](#) og Rådets pressemelding på bl.a. havneforbudet og veitrasportforbudet [her](#). Rådets pressemeldinger ble 22. april komplementert med pressemeldinger med informasjon om at også andre

europeiske land har varslet om at man vil slutte seg til sanksjonene. Se pressemeldingene nedenfor under «Rådets pressemeldinger uke -16:». Spenning knytter seg nå til når en sjette sanksjonspakke vil komme og hvilke tiltak som her foreslås.

Det franske formannskapet avholdt 8. april også et **ekstraordinært transportministermøte**. Transportministrene fokuserte her på tre temaer: 1) Hvordan bistå Ukraina for å sikre videre person- og varetransport, 2) Hvordan kan man beskytte utsatte transportarbeidere og 3) Hvordan man styrke transportsektorens robusthet. Pressemeldingen fra møtet kan finnes [her](#). Hva gjelder transportsektorens robusthet vises det til at Kommisjonen også har varslet en egen beredskapsplan på transport i år – i lys av erfaringene med pandemien. Det er grunn til å tro at denne planen også vil reflektere de foreløpige erfaringene med krigen.

Kommisjonen varslet 8. april også at man vil styrke **investeringene til transportinfrastruktur som både har et sivilt og et militært formål** («militær mobilitet»). I [pressemeldingen](#) varsles det om at Kommisjonen har valgt ut 22 prosjekter som vil bli tildelt støtte til en verdi av 339 millioner euro. I et [brev](#) datert 6. april oppfordret for øvrig en stor gruppe av europaparlamentarikere kommisjonsresidenten, den franske presidenten mf. om å styrke investeringene til militær mobilitet og å forenkle prosedyrene for tildeling av støtte.

11 EU-land (Danmark, Østerrike, Tyskland, Spania, Finland, Irland, Nederland, Luxembourg, Latvia, Sverige og Slovenia) sendte 7. april også ut en felles [uttalelse](#), der det ble oppfordret til en «*...ambitious and swift implementation of the Fit for 55 package*» - som en respons på Ukraina-krigen og behovet for å gjøre seg uavhengig av russisk energi. Her fremheves bl.a. behov for å satse på fornybar energi.

Kommisjonen vedtok 11. april å legge til **21 russiske fly på EUs sikkerhetsliste** fordi flyene ikke er i henhold til internasjonale flysikkerhetsstandarer. Kommissær **Vălean** siteres slik i [pressemeldingen](#): «The Russian Federal Air Transport Agency has allowed Russian airlines to operate hundreds of foreign-owned aircraft without a valid Certificate of Airworthiness. The Russian airlines concerned have knowingly done so in breach of relevant international safety standards. This is not only a clear breach of the Convention on International Civil Aviation (the Chicago Convention), but it also poses an immediate safety threat ... I want to make it crystal-clear that this decision is not another sanction against Russia; it has been taken solely on the basis of technical and safety grounds. We do not mix safety with politics».

I Kommisjonens spørsmål og svar – [dokument](#) til EUs flysikkerhetsliste presiseres det også at vedtak begrunnet utifra flysikkerhetsmessige vurderinger og at dette ikke er en ny sanksjon. Russiske fly er allerede ilagt et sanksjonsforbud mot å fly i europeisk luftrom. Oppføringen på liste innebærer et klart signal om sikkerhetsrisikoen med å fly med disse flyene, også et viktig signal for personer utenfor Europa. Opphevelse av sanksjonsforbuddet vil ikke innebære at flyene strykes fra oppføringen på EUs sikkerhetsliste.

Kommisjonen vil 28. april orientere Europaparlamentets Transportkomite om **konsekvensene av Ukraina-krigens for transportsektoren**. Straks deretter vil TRAN-komiteen stemme over en resolusjon med tittelen: «European Parliament resolution on the impact of Russian illegal war of aggression against Ukraine on the EU transport and tourism sectors». Resolusjonsutkastet kan finnes [her](#). I utkastet oppfordres bl.a. Kommisjonen om å gjennomføre en analyse av transportkonsekvensene og raskt presentere eventuelle tiltak. Transportkomiteen diskuterer forslag til revisjon av direktiv om infrastruktur for alternative drivstoff (AFIR) og ReFuelEU Aviation - forslaget

Transportkomiteen diskuterte **AFIR-forslaget** 19. april. I tillegg til saksansvarlig, MEP Ertugs (S&D, Tyskland) [rapport](#) med endringsforslag, har det kommet inn over 1000 forslag fra andre europeparlamentarikere.

MEP Ertug mener direktivet til nå har hatt en «viss positiv innvirkning» på utrulling av alternativ drivstoffinfrastruktur i Europa, men legger til at manglene er synlige. Direktivet har ikke klart å oppfylle hovedmålet; Å sikre en sammenhengende markedsutvikling av alternativ drivstoffinfrastruktur i EU. Han støtter bl.a. Kommisjonens forslag om å gjøre direktivet om til en forordning, innføre bindende minimumskrav og å sette år 2025 som tidsfristen for el-infrastruktur for lette kjøretøy – både på TEN-T kjernenettet og det mer omfattende TEN-T nettet. For tyngre kjøretøy foreslås det også en raskere utrulling av el- og hy-infrastruktur, mens forslag til krav til LNG-infrastruktur foreslås tatt ut av regelverket pga. «... risk stranded assets and detrimental lock-in effects in fossil technologies at the expense of sustainable alternatives with a higher potential to reduce emissions». Det foreslås også krav til jernbanen (elektrifisering).

Forslaget ble også diskutert i Rådets COREPER-gruppe før påsken. Diskusjonsdokumentet til denne diskusjonen kan finnes [her](#). Forslaget vil stå på agendaen til transportministermøtet 2. juni. Plenumsbehandlingen i Europaparlamentet er satt til medio september. Forutsatt at EP og Rådet får vedtatt sine posisjoner i tråd med denne tidsplanen kan trilogforhandlinger om endelig regelverket påstarte til høsten under det tsjekkiske formannskapet.

Transportkomiteen diskuterte også **ReFuelEU Aviation** – forslaget 19. april. I tillegg til saksansvarlig, MEP Gades (Renew, Danmark) [rapport](#) med endringsforslag, har det kommet inn ca. 400 endringsforslag fra andre europeparlamentarikere. Definisjonen av bærekraftig drivstoff, virkeområdet, SAF-kravene, muligheten for å sette egne nasjonale SAF-krav og «tankering»-problematikken, dvs. at fly bringer med ekstra drivstoff for å slippe tanking på EU-lufthavner, var temaer som kom opp i diskusjonen.

MEP Gade, som bl.a. foreslår å utvide virkeområdet for forslaget og en «SAF flexibility mechanism», dvs. en mulighet til å blande inn SAF på en kostnadseffektiv måte i en overgangsperiode, avrundet debatten med å uttrykke håp om å nå en mer ambisiøs posisjon enn den som Kommisjonen opprinnelig foreslo.

Forslaget vil stå på agendaen til transportministermøtet 2. juni. Plenumsbehandlingen i Europaparlamentet er satt til primo juli. Forutsatt at EP og Rådet får vedtatt sine posisjoner i tråd med denne tidsplanen kan trilogforhandlinger om endelig regelverket allerede starte til sommeren.
