





# Working Together for a Green, Competitive and Inclusive Europe

EUR 214.6 million has been allocated to a number of cooperation programmes with Hungary through the EEA and Norway Grants (2014-2021). These programmes are designed to strengthen cooperation between Norway and Hungary and to promote social and economic development in Hungary.

Support for civil society will remain substantial. Energy and climate change will be important focus areas, with an emphasis on climate change mitigation and adaptation and geothermal energy. Another focus area will be business development, where green industry innovation will be a main priority. Local and regional development and social inclusion of the Roma people will also be key priorities.

Six Norwegian agencies are involved as partners in implementing the programmes and are providing assistance with the recruitment of Norwegian project partners.

## ABOUT THE EEA AND NORWAY GRANTS

The EEA and Norway Grants have their basis in the EEA Agreement. Under the EEA Agreement, Iceland, Liechtenstein and Norway are part of the EU internal market. The EEA Agreement sets out the common goal of working together to reduce social and economic disparities in Europe and strengthen cooperation between donor and beneficiary countries. Iceland, Liechtenstein and Norway have allocated EUR 2.8 billion to the EEA and Norway Grants for efforts in 15 EU countries for the period 2014-2021. Norway provides just under 98 % of this amount.

The EEA and Norway Grants are an important tool in the Norwegian Government's active European policy, which seeks to promote a green, competitive and inclusive Europe.
